1. The terms of the Company (i) self-allotted copies of PAN Cards of all Equity Shareholders, (ii) any other relevant documents such as power of attorney, corporate authorisation including board resolution (specimen signature), relevant copy of death certificate and succession certificate or probated will, if the original Shareholder is deceased, etc., as applicable, in addition, if the address of the Equity Shareholder has undergone a change from the address registered in the Register of Members of the Company, the Equity Shareholder will be required to submit a self-allotted copy of address proof consisting of any one of the following documents: valid Aadhar card, voter identity card or passport.

2. Based on these documents, the concerned Shareholder Broker shall place or order on behalf of the Equity Shareholders holding Physical Shares who wish to tender Equity Shares in the Buyback, using the acquisition window of NSE. Upon placing the bid, the Shareholder Broker shall provide a TRS generated by the exchange trading system to the Equity Shareholder TRS will contain the details of order submitted like bid no., certificate no., deductive no., no. of Equity Shares tendered etc.

3. Any Shareholder Broker/Equity Shareholder who places a bid for physical Equity Shares, is required to deliver the original share certificates (as documents as mentioned above) along with TRS generated by exchange trading system upon placing of bid, either by registered post, speed post or courier or hand delivery to the Registrar to the Buyback Offer (i.e. Link Intime India Private Limited) (at the address mentioned at paragraph 14 below) not later than 2 (two) days from the offer closing date. The envelope should be super sealed as "Ajanta Pharma Limited - Buyback Offer 2020". One copy of the TRS will be retained by Registrar to the Buyback Offer and the self-allotted copy of the same to be returned to the Shareholder Broker.

4. Equity Shareholders holding physical Equity Shares should note that physical Equity Shares will not be accepted unless the complete set of documents is submitted. Acceptance of the physical Equity Shares by Buyback by the Company shall be subject to verification as per the Buyback Regulations and any further directions issued in this regard. The Registrar to the Buyback Offer will verify such bids based on the documents submitted on a daily basis and if a bid is not verified, NSE shall display such bids as unverified physical bids. Once Registrar to the Buyback Offer confirms the bids, they will be treated as confirmed bids.

11.3 METHOD OF SETTLEMENT

Upon initiation of the needs of acceptance as per Buyback Regulations:

1. The Company will consider to Company's Broker who will transfer the funds pertaining to the Buyback to the Clearing Corporation's bank account as per the prescribed schedule. For Equity Shares accepted under the Buyback, the Equity Shareholders will receive funds paid in their bank account from the Clearing Corporation.

2. The Demat Shares bought back would be transferred directly to the demat account of the Company opened for the Buyback (the "Company Demat Account") provided it is indicated by the Company's Broker or it will be transferred to the Company's Broker to the Company Demat Account on receipt of the Equity Shares from the clearing and settlement mechanism of the NSE.

3. The eligible Equity Shareholders will ensure that they have the depository participant (DP) account active and updated to receive credit in case of return of Demat Shares, due to rejection of bid or non-acceptance in the Buyback.

4. Excess Demat Shares or unaccepted Demat Shares, if any, tendered by the eligible Equity Shareholders would be returned to them by the Clearing Corporation. Any excess Physical Shares pursuant to proportionate acceptance request will be returned back to the concerned Eligible Shareholders directly by the Registrar to the Buyback. The Company is authorized to sell the share equivalent and issue unaccepted share certificates for the unaccepted Physical Shares, if any, the Physical Shares accepted by the Company are less than the Physical Shares tendered in the Buyback.

5. The settlement of NSE and Clearing Corporation for Demat and Physical Shares shall be as per the SEBI Circulars and as prescribed by NSE and Clearing Corporation from time to time. For Demat Shares accepted under the Buyback, such beneficial owners will receive funds paid in their bank account as provided by the depository system directly to the Clearing Corporation and in case of Physical Shares, the Clearing Corporation will release the funds to the Shareholder Broker(s) as per secondary market payment mechanism. If such shareholder's bank account details are not available or if the funds transfer instruction is rejected by the Reserve Bank of India (RBI) / banks, due to any reasons, then the amount payable to the concerned shareholders will be transferred to the Shareholder Broker for onward transfer to such shareholders.

6. In case of certain shareholders i.e., NRIs, non-residents etc., who have some specific regulatory requirements pertaining to funds payout including those prescribed by the RBI who do not opt to settle through custodians,

the funds payout would be given to their respective Shareholder Broker's settlement accounts for releasing the same to such shareholder's account.

7. The Shareholder Broker would issue contract note to the Eligible Shareholders tendering Equity Shares in the Buyback. The Company's Broker would also issue a contract note to the Company for the Equity Shares accepted under the Buyback.

8. Equity Shareholders who intend to participate in the Buyback should consult their respective Shareholder Broker for payment of any cost, charges and expenses including brokerage that may be levied by the Shareholder Broker upon the selling Equity Shareholders for tendering Equity Shares in the Buyback (secondary market mechanism). The Company accepts responsibility to bear or pay such additional cost, charges and expenses including brokerage incurred solely by the selling Equity Shareholders.

9. The Equity Shares bought back will be extinguished in the manner and following the procedure prescribed in the Buyback Regulations.

12. RECORD DATE AND SHAREHOLDER ENTITLEMENT

12.1 As required under the Buyback Regulations, the Company has fixed Friday, November 13, 2020 as the record date (the "Record Date") for the purpose of determining the entitlement and the names of the shareholders, who are eligible to participate in the Buyback.

12.2 The Equity Shares proposed to be bought back by the Company, as part of the Buyback Offer shall be divided into two categories: (a) reserved category for Small Shareholders (a "Small Shareholder" is defined in the Buyback Regulations as a shareholder, who holds equity shares or other specified securities whose market value, on the basis of closing price of the Equity Shares on the record date and other specified securities whose market value, on the basis of closing price of such shares, as on record date, is not more than ₹ 2,00,000 (Rupees Two Lakh Only); and (b) the general category for all other shareholders.

12.3 In accordance with Regulation 6 of the Buyback Regulations, 15% (fifteen per cent) of the number of Equity Shares which the Company proposes to buyback, or number of Equity Shares entitled as per shareholding of Small Shareholders, whichever is higher, shall be reserved for the Small Shareholders as part of this Buyback.

12.4 Based on shareholding as on the Record Date, the Company will determine the entitlement of each shareholder to tender their Equity Shares in the Buyback. This entitlement for each shareholder will be calculated based on the number of Equity Shares held by the shareholder as on the Record Date and the ratio of Buyback applicable in the category to which such shareholder belongs.

12.5 In order to ensure that the same eligible Equity Shareholders, with multiple demat accounts do not receive a higher entitlement under the Small Shareholder category, the Company will club together the Equity Shares held by such shareholders with a common PAN for determining the category (Small Shareholder or General Category) eligible by the shareholder for the Buyback. In case of just shareholding, the Company will club together the Equity Shares held in cases where the sequence of the PINs of the joint shareholders is identical. In case of shareholders holding Physical Shares, where the sequence of PINs is identical and where the PINs of all joint shareholders are not available, the Company will check the sequence of the names of the joint holders and club together the Equity Shares held in such cases where the sequence of the PINs and name of joint shareholders are identical. The shareholding of individual investors (i.e. mutual funds, pension funds, insurance companies, foreign institutional investor foreign portfolio investors etc.) with common PAN are not proposed to be clubbed together for determining their entitlement and will be considered separately, where these Equity Shares are held in different schemes/sub-accounts and have a different demat account nomenclature based on information provided by the Registrar to the Buyback as per the shareholder records received from the Depositories. Further, the Equity Shares held under the category of "Voting members" or "corporate body" or "corporate body" - broker as per the beneficial owner details as on Record Date with common PAN are not proposed to be clubbed together for determining their entitlement and will be considered separately, where these Equity Shares are assumed to be held in the name of clients.

12.6 The eligible Equity Shareholders' participation in the Buyback will be voluntary. The Equity Shareholders can choose to participate and get cash in lieu of Equity Shares to be accepted under the Buyback or they may choose not to participate and enjoy a resultant increase in their percentage shareholding, post Buyback, without additional investment. The eligible Equity Shareholders may also accept a part of their entitlement. The Equity Shareholders also have the option of tendering additional shares over and above their entitlement and participate in the shortfall created due to non-participation of some other Equity Shareholders, if at all.

12.7 The maximum tender under the Buyback by any shareholder cannot exceed the number of Equity Shares held by the shareholder as on the Record Date.

12.8 The Equity Shares tendered to be the entitlement by shareholders as well as additional shares tendered, if any, will be accepted as per the provisions laid down in Buyback Regulations.

12.9 Detailed instructions for participation in the Buyback (tendering of Equity Shares in the Buyback) as well as the relevant time table will be included in the Letter of Offer which will be sent in due course to the Equity Shareholders as on Record Date and the Company shall comply with the SEBI (Buyback of Securities) Regulations, 2015 (SEBI (Buyback of Securities) Regulations, 2015) dated July 14, 2020 and SEBI (Buyback of Securities) Regulations, 2015 (SEBI (Buyback of Securities) Regulations, 2015) dated July 27, 2020 on "Matters relating to procedural matters - Takeovers and Buyback".
